New Sheridan Emergency Department Begins to Take Shape, Thanks to Historic Level of Community Generosity

As our regional community continued a historic display of generosity in support of our campaign for the new Sheridan Emergency Department in 2025, the vitally important new facility began to take shape before our eyes.

On June 19, campaign and community leaders were joined by some of the campaign's lead donors and representatives of the hospital's 3,600 health care professionals and support staff for a ceremonial groundbreaking celebration on the site where the Emergency Department's 7,700-square-foot addition would soon rise.

Representing the lead donors who have made this project possible were Davene Brown and family of the David S. and Janet R. Sheridan Family Foundation; Charnelle Hoopes Thompson and Maggie Hoopes of the Hoopes Family Foundation; Charlene Wood, Chelsea Silver, Tenee Casaccio, and Mark Behan of the Charles R. Wood Foundation; and Joanne Conley and Regina Conley Bethel of the Conley/Salice family. The project was also the recipient of a wonderfully generous \$15 million grant from New York State in recognition of the essential role the Emergency Department plays for residents and visitors across a five-county, 6,000-square-mile region.

By the end of the year, the Emergency Department's completely renovated Reception & Waiting Area and patient Triage area were nearing completion. The Emergency Department parking lot was reconfigured, and the helipad was relocated to make room for the major expansion.

Construction of the addition will continue into the beginning of the second quarter of 2026, at which time attention will shift to renovating and modernizing other emergency patient care areas. The entire modernization project is scheduled to be completed by early 2027. At that time, the Department will feature separate care areas based on the severity of patients' conditions, twice as many rooms for the most seriously ill patients than are currently available, and a dedicated CT scanner for faster

diagnosis and treatment. The expanded and modernized Department will provide the Emergency Department team – whose expertise and skills are more advanced than ever before – the facilities they need to deliver the more private, personalized and comfortable patient experience we all deserve.

Since the start of the Community Campaign in 2024, the Hospital Foundation's goal has been to raise 100% of the Emergency Department project costs from public and private sources so that our Hospital incurred no further debt, and that is becoming a reality.

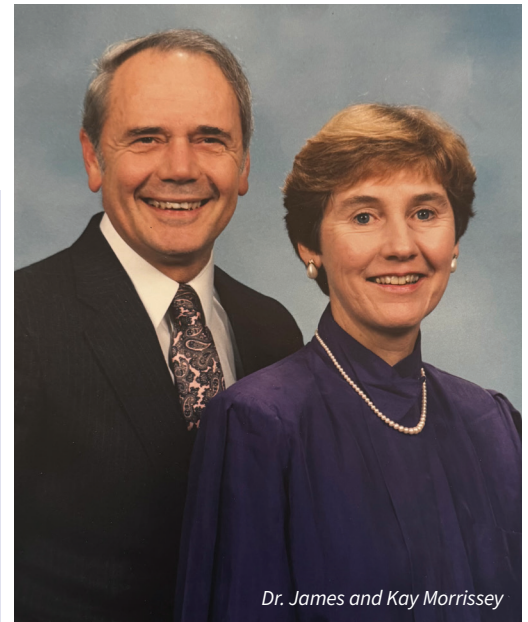

A SPECIAL HONOR FOR TWO SPECIAL PEOPLE

Dr. and Mrs. Morrissey Recognized with Special Tribute Gift from Friends, Family

Dr. James F. Morrissey and his wife, Kay, have shaped the Glens Falls community through a lifetime of service, leadership, and quiet generosity.

Thanks to the reciprocal generosity of dear friends Bill and Lisa Powers' \$250,000 tribute matching gift, and gifts from the Morrissey's children and friends from throughout the region, a donation of more than \$500,000 has been made to the Sheridan Emergency Department in Jim and Kay's name. With this gift, the Morrisseys will be prominently honored through the naming of a nurses' station.

Raised in a small western New York farming town and educated in a one-room schoolhouse, Jim's journey—from Cornell University to the University of Rochester School of Medicine—reflects a deep commitment to learning and service. After serving his country in the Army in Germany, he settled in Glens Falls as the community's only cardiologist at the time, dedicating his career to caring for neighbors and strengthening local healthcare.

Jim founded Adirondack Cardiology and served on the boards of Glens Falls Hospital and Hudson Headwaters Health Network, helping guide the region's medical future. A lifelong learner, he continues to embrace curiosity, travel, and connection. Kay was a dental hygienist before raising their family of six children, all

Glens Falls High School graduates. As a natural caregiver and CEO of a large and busy family, she managed it all, rarely missing a game, meet or performance for any of her children. Their home was the gathering place for all their children's friends, and she was a second mom to many.

Together, Jim and Kay built a family life rooted in community traditions and shared experiences. Over decades, the Morrisseys have generously supported organizations that serve the most vulnerable, including Glens Falls Hospital, YMCA, Adirondack Outreach, Glens Falls Family Services, the Glens Falls Area Youth Center, Wait House, Family Service Association, St. Mary's Church, Meals on Wheels, the Hudson Headwaters Health Network, and North Country Ministry.

A SIGNATURE MOMENT

Guests at the June 19, 2025 groundbreaking ceremony for the new Sheridan Emergency Department and that evening's SAVOR event signed a steel beam that was later placed over the entrance to the department's 7,700-square-foot addition. 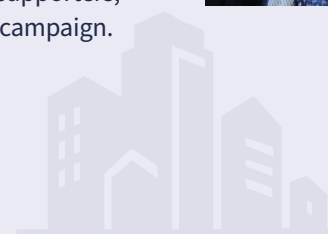
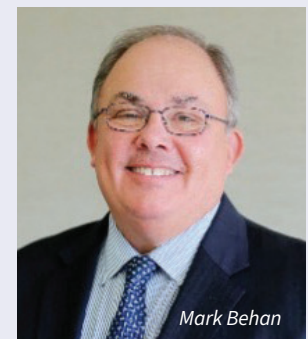

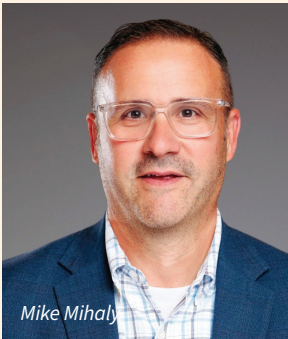

and charitable remainder trusts, which can result in significant tax savings. We are always pleased to work with donors so that they can meet their philanthropic goals. We honor those donors through membership in the 1897 Legacy Circle and by recognizing them in our annual report, keeping them up to date on hospital news and inviting them to events.
